WAIVER AND RELEASE: I hereby grant to The Recording Academy and its successors, affiliates, licensees, subsidiaries and assigns, and any third parties authorized by one of the foregoing (collectively, "Recording Academy Parties"), the irrevocable right, license and authority in perpetuity and throughout the world to use, record, dub, amplify, reproduce, perform, represent, exhibit, televise, transmit, and simulate my name, image, likeness, photograph, voice, work product and musical performances in any and all manners, forms, media, methods and processes now or hereafter known or devised, in and in connection with the Event and recordings thereof, and publicity and advertising materials associated with or related to the Event or The Recording Academy Parties. I acknowledge that there are to be no protected pre-existing sampled music or images in my recordings and performances, and that all recorded and performed work will be entirely original. I further acknowledge and agree that The Recording Academy Parties shall have the irrevocable right, license and privilege to reproduce, distribute and otherwise use recordings of my voice and/or musical performances for both promotional purposes as well as for commercial sale throughout the world, in any and all manners, forms, media, methods and processes now and hereafter known or devised. All proceeds from any such uses or commercial sales will be entirely the property of The Recording Academy, and I acknowledge and agree that I will not be entitled to any royalties, fees or other payments from such activities and waive any claim to such payments. I further hereby release and waive any and all claims I may have against the Recording Academy Parties and their respective employees, officers and directors for any and all injuries, claims, damages, losses, costs or expenses of any kind arising from or related to my participation in the Event, including without limitation my travel to and from the Event. I further agree to indemnify and hold harmless the Recording Academy Parties from and against any and all third-party claims, liabilities, costs and expenses (including attorneys' fees reasonably incurred) arising out of or related to any breach or alleged breach or violation of this document by me and my participation in the Event. This document and its interpretation shall be governed pursuant to California law, and I hereby consent to the exclusive jurisdiction and venue of California courts (state and federal) for any cases or controversies arising out of or related to this document. I further waive any and all objections to jurisdiction and venue in those courts.
